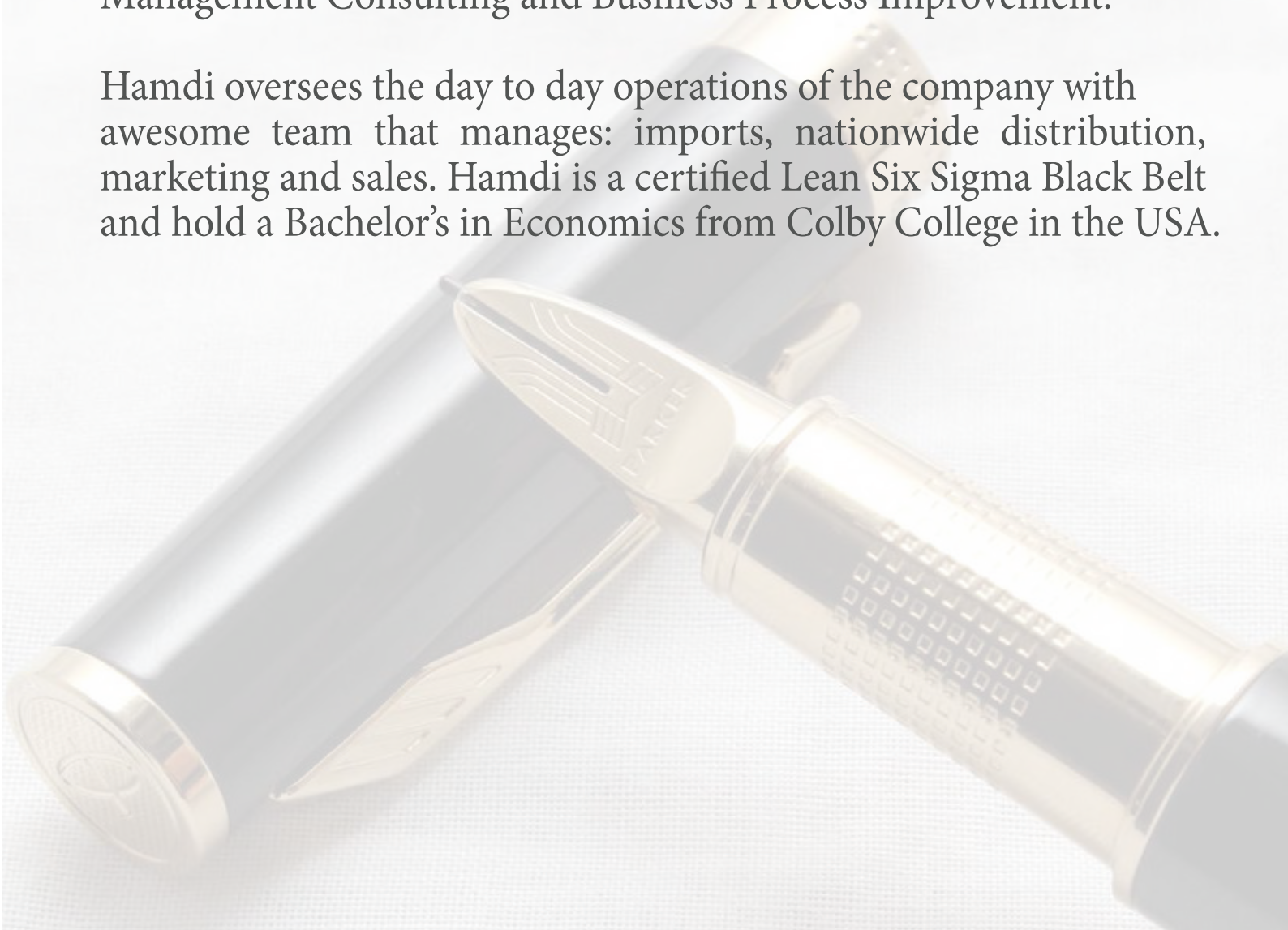

As Operations Manager, Hamdi brings 6 years of experience in Management Consulting and Business Process Improvement.

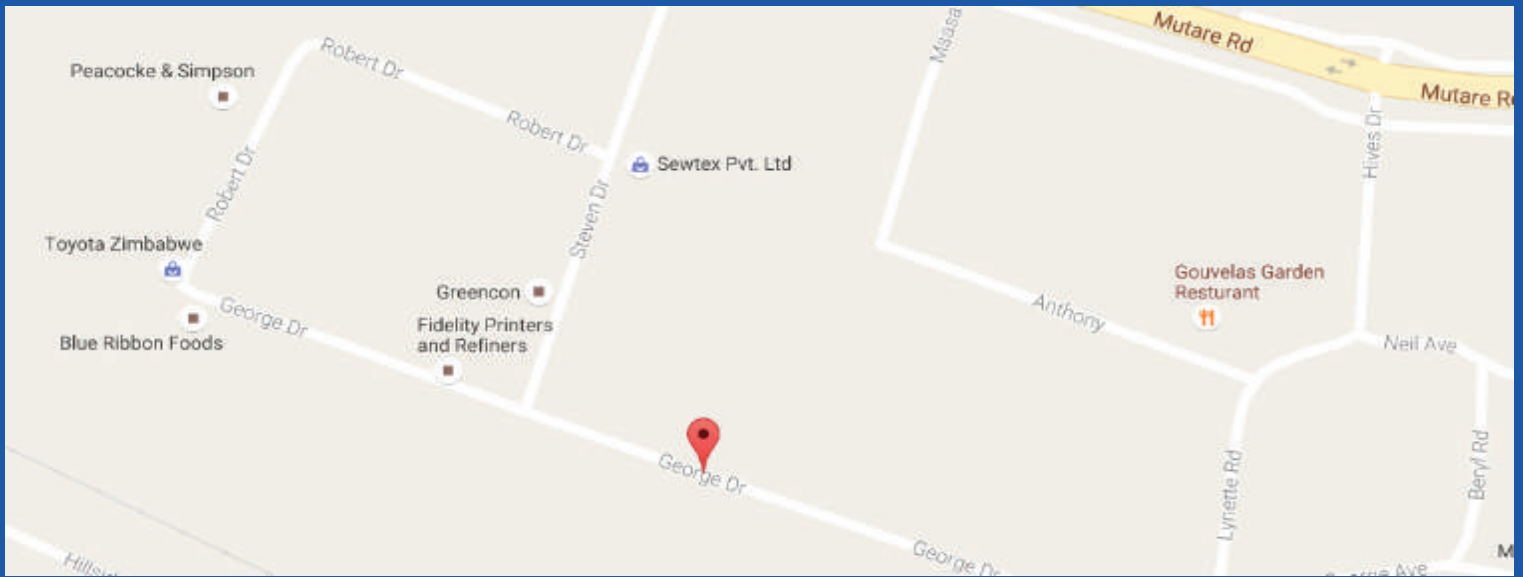


